Saturday, July 10th Arbor Vitae Fireman's Park
Always 2nd Sat. in July Hwy 70 East - Arbor Vitae
9:00 a.m. to 3:00 p.m. 1½ miles east of junction
Hwy 51 & Hwy 70E

Check-in time is Saturday morning from 5:00-8:00 a.m.

Location provides ample parking for exhibitors and customers indoor rest rooms, and food & refreshments at park pavilion.

Awards: Awards of Excellence (cash & ribbon) and Honorable Mentions (ribbon only). Awards will be based on the individual artist's entire presentation, excellence & originality regardless of medium. The judging will take place between 8:00 a.m. & 11:00 a.m. The awards will be presented and the awards list will be posted in the information tent by 1:00 p.m.

Entry Fee: A non-refundable fee of \$70 for each 12' x 12' space. Entry fee will be returned if your entry is not accepted. Entries received after deadline (if space available) are \$95 and is non-refundable.

Entry Deadline: June 1, 2010

Eligibility: Open to amateur and professional artists in the following media and forms provided each piece is executed by the artist exhibiting.

- PHO - Photography
- FA - Paintings, Drawings, Graphics
- SC - Sculptures (Stone, Metal, Clay and Soft Sculptures)
- CAR - Carvings, Wood and Natural Materials
- DP - Decorative Painting, Rosemaling, Tole, Painting on Wood
- PO - Pottery TE - Textiles JE - Jewelry
- WO - Woodworking, Furniture, Hand-crafted Wooden Items
- NA - Natural Crafts, Basketry, Leather, Paper
- WNF - Wood and Fabric SG - Stained Glass

2- Dimensional Fine Arts: all hanging artwork must be original in concept, design and composition and executed by the artist exhibiting.*

Limited edition prints are allowed, but must be displayed in bins or art racks. Judging will be on original art only.

Unacceptable: artwork produced from patterns, step by step instructions, copies of another artist's work. **Unacceptable** are items made from commercial molds or kits, stencils or forms.

3- Dimensional Fine Arts & Crafts: Each piece must be of quality work and the entire article made from raw materials. The raw materials must under go a change in shape and appearance into something other than what it was.

Attention Decorative Painters & Crafters! If your display includes two-dimensional drawings or paintings they must conform to the criteria listed under 2-dimensional art.

Photo submissions: Submit 5 photos giving an accurate and complete representation of all items that will be included in your booth. Each photo must be clearly marked with exhibitor's name, address & medium. The committee will keep 1 or 2 photos for future reference. Photos will be returned after show upon request.

Consistency of works of art with photos: If an artist's works on display are not consistent with the quality of work shown in photos, or if the artist shows reproductions or other prohibited items, the artist will be asked to eliminate those items from the booth or may be asked to leave the fair. Judgment of the Committee in this matter will be final, and no refunds will be given.

Jury Committee Selections: The jury committee will meet each week to make their selections. Notices of acceptance or rejection will be mailed on those days. Jury committee reserves the right to accept or reject any entry. **A stamped self addressed envelope must be enclosed with the Entry Blank.***

Cancellations, No-Shows & Fail To Set Up: Cancellations will not be accepted after June 1st. A No-Show or Failure To Set-Up will affect your acceptance into future Art Fairs.

Display: Exhibitors will be responsible for creating an attractive display. All display material must be furnished by the exhibiting artist - including protection from the weather. Exhibitors are urged to have an assistant to help unload, set-up and watch their display. Fair committee will not be liable for any loss or damage.

Sales Taxes: Collection & payment of WI State (5%) and Vilas County (.5%) sales tax is the responsibility of the exhibitor. Social Security number and Wisconsin Seller's Permit number must be included on the Entry Blank.

Registration & Unloading: Check-in time is Saturday morning between 5:00-8:00 a.m. at the drive up checkpoint located at the Park Entrance. You will receive your space number at this time. Exhibitors are to be unloaded & vehicles moved to designated exhibitor parking lot by 8:30 a.m.

No Motorized Vehicles allowed in the exhibit area before, during or after the fair. This rule is strictly enforced for the safety of all concerned and to comply with our insurance requirements. If you have extremely heavy objects (ie: wrought iron or wooden furniture), please request a perimeter space.**
